Coalcyn Equestrian LLC agrees to make every attempt to provide viable fresh, cooled semen shipped Monday-Friday or available for pickup any day. However, due to a busy competition schedule it is advised that the Mare Owner gives 7-14 days notice to confirm that the stallion is available for collection during the timeframe that the Mare Owner desires. Please request semen by 9pm PST the night before semen needs to be shipped. If semen is needed the day of, every effort will be made, but no guarantee can be offered. As part of this Contract the first collection is included in the stud fee of \$1,350 and shipping will be charged at a flat rate of \$250. Each additional collection will be charged for \$175 and shipping for a flat rate of \$250. No semen will be shipped until the stud fee is paid in full and shipping/collection fees are due within 48 hours.

This agreement is to produce one foal from the above-mentioned Mare, regardless of the breeding methods used. Should the dose of semen be utilized via dose splitting, embryo transfer or ICSI and results in more than 1 live foal from the mare described above an additional fee of \$1000 will be charged. If semen is used for a mare other than mentioned in this agreement an additional contract will be required. If the Mare Owner violates a provision of these terms and conditions, Coalcyn Equestrian LLC will impose a contractual penalty of \$2,500.

In the event of the Stallion's death or inability to produce viable semen. Coalcyn Equestrian LLC will issue a refund of the initial stud fee, but there will be no refund for previous collections/shipping.

Should the mare be unable to produce a viable foal, Coalcyn Equestrian LLC offers return privileges to the above listed Mare during the breeding season and offers return breeding privileges for 36 months following the signing of this agreement. A mare may be substituted for a \$200 fee with written permission from Coalcyn Equestrian LLC. This contract is only transferable upon approval with written permission of Coalcyn Equestrian LLC.

This Contract comes with a 3 year Live Foal Guarantee. Should the Mare not produce a live foal or one that does not survive past 30 days from birth, the Mare Owner is entitled to rebreed privileges within 12 months. This guarantee only applies if Coalcyn Equestrian is notified within 48 hours of the foal's death. A veterinary record issued by a licensed veterinarian must be supplied within 14 days of the foal's death.

It is understood that the Mare Owner is taking all liability and risk by breeding the Mare. It is advised that the Mare is in good health and condition, provided with high quality nutrition, a proper vitamin and mineral program. Mares provided with proper veterinary care are more likely to conceive on the first try and produce viable healthy offspring.
